

Turkey REACH (KKDIK) updates

Free webinar

KKDIK is an acronym in Turkish for Registration, Evaluation, Authorization and Restriction of Chemicals. KKDIK, entered into force on 23 June 2017, is the Turkish Regulation on Chemicals Registration, Evaluation, Authorization, and Restriction.

Like EU-REACH regulation, the KKDIK regulation also requires companies to pre-register and register all substances manufactured or imported in Turkey. KKDIK has become one of the most sought-after compliance services, since the deadline of KKDIK's pre-registration (pre-SIEF notification) is approaching (31 December 2020). After this deadline, only companies that have pre-registered their substances would be allowed to place chemical substances in Turkey.
